MAKING NEIGHBORHOODS SAFER

When I first ran for this job, I promised to reinvigorate the effective Neighborhood Prosecutor Program, pledging to double it. We did that and then some, tripling the number of Neighborhood Prosecutors. These are Deputy City Attorneys who are embedded in our communities working to tackle tough public safety issues.

For the last eight years, your Neighborhood Prosecutor in LAPD's Wilshire Division has been the marvelous Nooshi Zahiri. Nooshi has been indefatigable in her work with the Miracle Mile community and other partners to improve the quality of life here. (Cont on pg 3)

THE STATE OF LOS ANGELES FAMILY LAW By Maureen Stubbs ESQ. CFLS




I had the good fortune earlier this year to be invited by my former colleague, David Glass, to join the family law department of ENENSTEIN PHAM & GLASS LLP (EPG) on an "Of Counsel" basis. What is Estate Planning?

Many people think that estate planning is simply the writing of a will. People plan their estate because they want to control who will receive their assets after they die, preferably with as little as possible going to legal fees and taxes. As you will see, for most of us, estate planning encompasses much more than the simple writing of a will or what happens after you die. A good estate plan will also protect you in the event of your incapacity. It will let you - not the courts - keep control of your assets, as well as control of decisions about your medical care and financial affairs when you can no longer handle on your own.

The best time to plan your estate is now – while you can and before you need it. With estate planning, there is no second chance. None of us like to think about our own mortality or the possibility of becoming incapacitated. That is exactly why so many families are caught off guard and unprepared when incapacity or death occurs.

What is my Estate?

WHAT IS A NOTARY PUBLIC? By Mobile Notary Public Kristi Tarpley



What is a Notary Public? A Notary Public is an official appointed by the California Secretary of State and authorized to serve the public as an unbiased witness when performing many legal formalities relating to the drafting or certifying of contracts, deeds, Powers of Attorney, Trusts, various estate planning documents and other official documents. Having a document notarized assures the parties to a transaction that a signature is authentic and can be trusted. It is important to note that Notary Publics are NOT Attorneys, we cannot give any legal advice.

What does a Notary Public do? A Notary Public can perform a variety of duties, but only in the state they are commissioned in, which include:

- Witnessing the signing of documents or administering oaths
- Administering oaths and affirmations during court proceedings and when officials are sworn into office.
- Maintaining proper records of their activities as mandated by their state.

As a Notary, it is my duty is to screen signers of important documents for their true identity, their willingness to sign without duress or intimidation, and their awareness of the contents of the document or transaction. The most common form of proof of identification that signers would need to show for proof of their true identity would be a state issued ID, such as a current Driver's License or State Identification card. Current passports are also acceptable. There are a few other acceptable forms of proof of identification, but it can get tricky and really depends on the situation.

PREVENTING GUN VIOLENCE

Throughout my public service career, I have led efforts to prevent gun violence. One of the first things I did when assuming this office in 2013 was to create the Gun Violence Prevention Unit to work aggressively to keep guns out of the hands of criminals and kids. Putting adults on alert, we brought charges against parents who do not properly store their guns which later fall into the hands of their kids - tragedies waiting to happen. I've worked with LAPD to create new protocols to assure that domestic violence perpetrators cannot get weapons, given the chilling link between domestic abuse and gun violence: abused women are five times more likely to be killed when there is a gun in the house. Following the mass school shooting in Parkland, Florida, I convened the Blue Ribbon Panel on School Safety, charged with examining, evaluating and recommending ways to enhance efforts by LAUSD to keep students safe from violence, particularly gun violence, both in schools and surrounding neighborhoods. Our panel received hundreds of comments and suggestions in public hearings across L.A., and submitted 33 important recommendations to the School District. More recently, I issued an eight point plan to address the surge in gun crimes we've seen across our City. And I was a founder and co-chair of the national coalition, Prosecutors Against Gun Violence.

GRAPPLING WITH OUR HOMELESSNESS CRISIS

All of us need to go well beyond our traditional roles to confront our homelessness emergency. For the first time in the history of the Office, I appointed a senior City Attorney to lead our homelessness work. My office has successfully intervened, time and again, to stop the unlawful discharge of homeless patients to the street, changing(the practices of medical facilities throughout the region. We initiated efforts to use motels to house people experiencing homelessness. My office created a program that sends teams of a nurse, substance abuse... (Cont. pg 4)

",expert, mental health expert and caseworker to some of L.A.'s grittiest encampments, intervening to provide an array of services to people experiencing homelessness. Because old outstanding fines, citations and warrants can impede people experiencing homelessness from getting the housing, services or jobs they need, we established a program that has helped erase these impediments when participants connect with programs to help lift them out of homelessness

TAKING AGGRESSIVE ACTION ON COVID-19

When the pandemic hit hard in March of 2020, my Office took swift action, targeting price gougers online and in brick and mortar stores; successfully combating fake tests and cures; launching "Behind Closed Doors" to help domestic violence victims trapped with their abusers; partnering with Mayor Garcetti on "LA Represents," the unprecedented legal assistance initiative helping thousands of Angelenos facing hardship due to the crisis; and, hosting the Hate Crime Prevention Forum in response to hate incidents targeting the Asian American Pacific Islander Community. Recently my office reached a groundbreaking \$22.5 million settlement with a national COVID testing chain, Sameday Health, over allegations that it faked and forged COVID-19 test results.

PROTECTING CONSUMERS

We also have focused on protecting our most vulnerable residents including kids, seniors, immigrants and disabled residents. We were the first government entity on to Wells Fargo for the millions of fake accounts set-up without customer permission, resulting in a landmark national settlement requiring Wells Fargo to provide restitution to affected customers and pay \$50 million in civil penalties, the largest such payment in the history of the City Attorney's office.

...schooling children, have made the decision to separate. Initially, we observed a lot of economic uncertainty while couples delayed separating until they could sort out their finances before taking action to transition to separate households. These couples are now finding their way to our offices and filing for divorce. While the courts have kept the doors open, virtually, if not always in person for critical matters like Restraining orders, other family law cases have been pushed to the back burner. As one attorney put it, "while the courts have not shut down, access to justice has slowed down".

Not surprisingly, resolving divorce, custody and support matters by the cost effective method of mediation is becoming a first choice by many couples. The mediation process can effectively provide couples with a resolution that they personally create, rather than a courtmandated solution. It affords the couple the opportunity to deal with underlying personal/emotional issues which are thrown under the rug during litigation, often defeating a settlement. Couples have a long and personal history with one another, and as a result, emotions sometimes run rampant; often, there are underlying issues that need to be sorted through before financial matters can be addressed. Oftentimes, parties naturally feel tense and adversarial during a divorce. This can deter the couple from making the appropriate and beneficial decisions regarding their individualized needs. Sometimes, one party may put up a tough fight, but all he or she wants is some acknowledgment and appreciation before making some concessions. Taking a non-confrontational approach to divorce leads to higher personal satisfaction due in part to the required active involvement and cooperation of the parties themselves in resolving issues in their divorce. For families with children, the therapeutic nature of mediation provides parents the opportunity to formulate long term goals and create a parenting plan in the best interest of their children and family. (Feuer Cont) ... vaping companies to stop sales to minors, stopped immigration fraud targeting vulnerable residents, played a leading role in getting taxpayers restitution for allegedly unfair and deceptive practices tied to ostensibly free online tax preparation services, and much more.

REDUCING RECIVIDISM THROUGH INNOVATIVE CRIMINAL JUSTICE ACTION

In 2014, I established a neighborhood-focused initiative to reduce crime, assist victims, and turn around the lives of nonviolent offenders. This Neighborhood Justice Program (NJP) is a pre-filing diversion program in which first-time offenders and other eligible individuals repair the harm they caused through a community-based process, instead of in a courtroom. It requires the individual to take responsibility while avoiding having a criminal record. And it has been a remarkable success. Since its inception, NJP has accepted thousands of participants, with a recidivism rate of only 5%--a dramatic improvement over the results of traditional misdemeanor prosecution. In addition, NJP participants have completed tens of thousands of hours of community service to improve our neighborhoods. Hundreds of community volunteers participate in this effort, frequently reporting how rewarding it is to make a difference in their neighborhoods.

COMBATING WAGE THEFT

Standing up for workers, my office won hundreds of thousands of dollars in back wages for home health care workers who so often are exploited, and secured more than \$1M in restitution for car wash workers deprived of minimum wages, overtime and rest breaks. We have sued three Port of Los Angeles trucking companies alleging each had misclassified truckers working for them as "independent contractors," instead of "employees" in order to evade their obligations to provide benefits and pay relevant taxes.

IN CLOSING

I was deeply honored when the American Bar Association selected our Office as the winner of its top award in the nation for a public law office--the prestigious Hodson Award. We are the first and only City Attorney's Office in America ever to receive this distinguished award.

Well, I've run out of room, and I've barely scratched the surface of the groundbreaking, impactful work that the dedicated members of the City Attorney's Office have achieved. Thank you so much for the great privilege to serve as your City Attorney, State Assembly Member and Councilmember. Whatever my next chapter may be, I look forward to continuing working with you, the wonderful people of the Miracle Mile.

What if I do no Estate Planning?

If you die intestate (without a will), then California's laws the administration of a revocable trust (Living Trust). of descent and distribution will determine who receives your property by default. Contrary to popular belief, if you die without a will, everything you own does not auto- A revocable trust (sometimes referred as a "living trust") matically pass to the state. Typically, the distribution will be to your spouse and children and then to other family members (including half-siblings and potentially, stepchildren). The "state's plan" reflects the legislature's guess as to how most people would dispose of their estate and establishes protection for certain beneficiaries, particularly minor children. The rules of "instate succession" may or may not reflect your actual wishes. Estate planning affords you the opportunity to alter the state's default plan to suit your personal wishes.

Who needs Estate Planning?

What is a Will?

A will is a written document naming who you want to handle your final affairs (your Executor) and who you want to receive your assets after you die (your beneficiaries).

(Estate Planning Cont.) ...joint tenancy. Additionally, it does not control assets with beneficiary designations, like your IRA, retirement benefits or life insurance policies. With respect to assets that are controlled by your will, these assets will have to go through a courtcontrolled process called "probate".

What is Probate?

Probate is the name given to the court supervised process developed under State law which handles the administration and subsequent distribution of your assets pursuant to the terms and desires expressed in your will (or pass by intestate succession). In short, probate means the process by which your assets are gathered, applied to pay debts, taxes and expenses of administration, and distributed to those designated as beneficiaries in your will. After the notice is given, and a hearing is held, and if all is in order, your will is admitted to court.

While probate is a clear, orderly process, it can, in many in potential death benefits from your insurance policies, situations, be unnecessarily time-consuming and expenthe process will customarily consume at least 12-15 months, if not longer, and legal and executor fees may well be greater than comparable services rendered in

What is a Revocable Trust?

is a written agreement between the person creating the trust and the person named to manage the assets of the trust (typically yourself during your lifetime). The revocable trust will also name the person and/or financial institution who would handle your assets in the event of your disability and their distribution in the event of your death.

A revocable trust may be amended or revoked by you at any time during your life, as long as you are competent. The terms of the trust become irrevocable (not subject to change) after your death.

and probate fees as well as preventing the court from controlling your assets in the event of your incapacity.

As you can see, trusts are not only for the wealthy. Anyone desiring to control when or how their assets are distributed, following their death, should consider a revocable trust. A revocable trust can avoid probate at death, prevent court control of assets in the event of incapacity, provide privacy (since a revocable trust is not a public Unfortunately, your will only controls the assets that are document), allow speedy distribution of assets or control the distribution of assets following your death. Lastly, clear a background check and be fingerprinted. Once I passed all of this, I took an Oath and received my Notary commission. To maintain my commission, every three years, I must take a refresher course approved by the California Secretary of State and complete and pass a written examination prescribed by the California Secretary of State all over again.
